89. To receive apologies for absence.

b) To discuss any matters arising and vote on any recommendations listed below.

The following recommendations were agreed and approved by the Council:

To consider the principle of converting one of the tennis courts at the Recreation Ground into a Multi-use Games Area (MuGA).

It was agreed in principle converting one of the tennis courts at the Recreation Ground into a Multi-use Games Area. This would be added to the balanced score card for future prioritization.

To consider taking over open spaces from Breckland Council to facilitate improved play provision in the north of Dereham.

It was agreed that the Town Council take over open spaces from Breckland Council at Sandy Lane and Girling Road to facilitate improved play provision in the north of Dereham and request a 10-year maintenance contribution.

To consider matters to be included in the tendering for improved play provision in the north of Dereham.

It was agreed that the selected contractor be required to consult with local residents due to the play equipment being installed in close proximity to residential properties.

It was agreed that the Town Council ask families in the area who have children with disabilities to come forward and make suggestions for equipment which they have found of value, prior to the tenders being sent out.

The following recommendations were agreed and approved by the Council:

To consider taking over Management responsibilities for the Neatherd from Breckland Council.

It was agreed that the Town Council take over the Management responsibilities for the Neatherd from Breckland Council with a commuted sum of £120,000, commencing January 2024. Councillors felt that although the sum did not reflect the ongoing cost of management that Breckland Council would be passing over, it was still in the public interest for all responsibilities to sit with one authority.


To consider gritting routes.
